In Front

Musings on Markets, Industries & All Things Insider.

Last week was one of the slowest weeks of the year for insider filings. Besides summer holidays distracting insiders, many companies still have trading windows closed to their executives until June-quarter earnings are released.

Looking at the table of weekly stats at the top of Page 2 shows only 78 stocks had any open-market purchases at all last week. On the selling side, there were only 235 stocks with open-market sales, which is also a low number (although it's pretty typical that there were about 200% more open-market insider sales than purchases in any given week).

Looking at Page 7, only 14 of the 78 stocks with purchases had buys worthy enough to generate are perpetuated an existing "Significantly Bullish" [Insider Company Rating \(ICR\)](#). Adding in the nine names with ICRs "Leaning Bullish", and that adds to only 23 stocks last week for insider-oriented investors to consider.

Yet even during this slowest of weeks, insiders have still generated a good number of solid investment ideas.

Right off the bat, a handful of names jump out at me that I already know and like after researching them further when they entered my Bullish Universe weeks or months ago. These are (in order of appearance):

Alpha Cognition (ACOG);
Taiwan Semiconductor (TSM);
Mexico Fund (MXF), and;
Navios Maritime LP (NMM).

So if you need or want a high-risk/high-reward biotech, a megacap tech stalwart, a total-return play trading at a discount to NAV,

or a value stock well-positioned in the shipping biz, these stocks definitely have a "thumbs up" from both insiders and me. ACOG, TSM, and NMM further have all "Buy" ratings from their Wall Street analysts along with average price targets well above where they trade now.

Energizer (ENR) is another known name to me, but I've passed on ENR due to its lesser prospects.

Bank stocks are commonly well-represented in my Bullish Universe, and two new names entered that list last week: **Rhinebeck Banc (RBKB)**, and **Five Star Banc (FSBC)**. Insiders at RBKB bought into their bank's conversion from a mutual holding company to a publicly-traded firm, and execs at FSBC bought into a secondary offering.

Of this pair, FSBC gets my thumbs up. Five Star has impressive growth predicted for the next two years, and the proceeds from its raise are targeted towards even more growth opportunities. The dilution from the secondary also gapped FSBC down to a better entry point.

I've focused on biotech several times in this space over the past couple months, and insiders continue to indicate investors should stay overweight this industry by generating even more names to consider. **Artiva BioTherapeutics (ARTV)** and **Parabiolis Medicines (PBL)** both look promising to me, and I'm even ready to give ARTV an official thumbs up as well.

So that's at least six names on last week's seasonally short list of insider-bought stocks that I can justify buying into, and I haven't even finished looking deeper into the entire list of 23 stocks on Page 7. **Which all goes to prove yet**



again that—even during the slowest week of the year for insider filings—insiders are the best Idea Engine around!

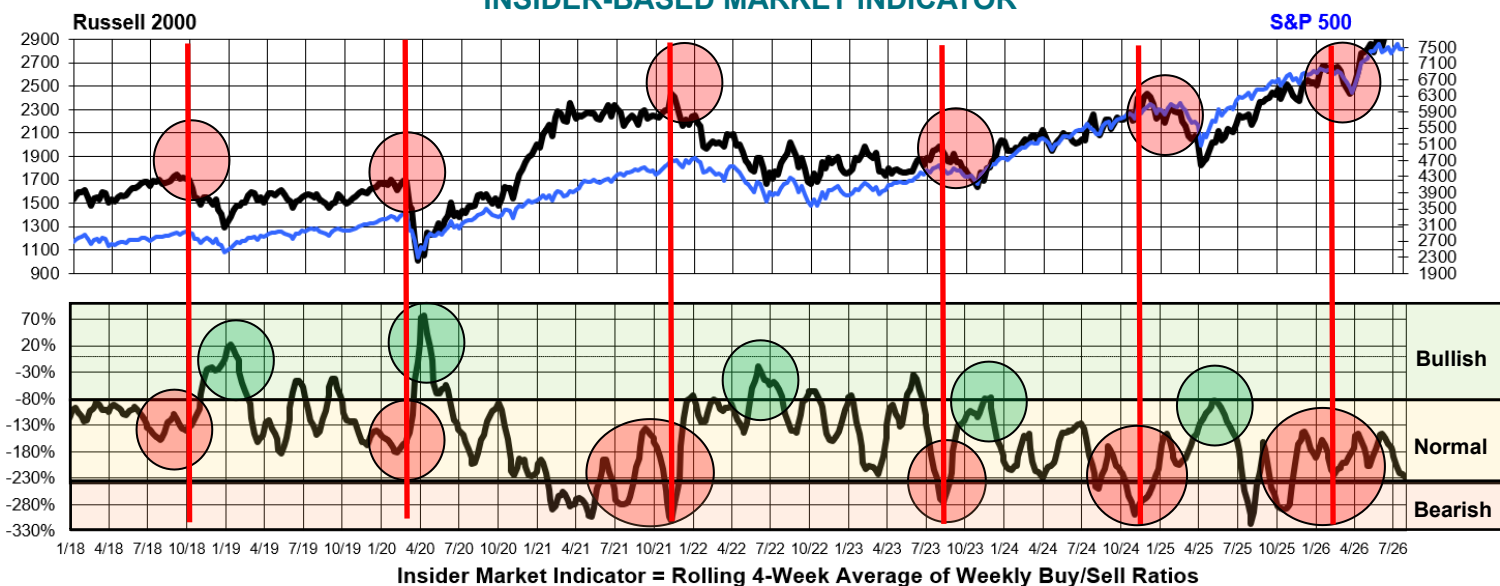

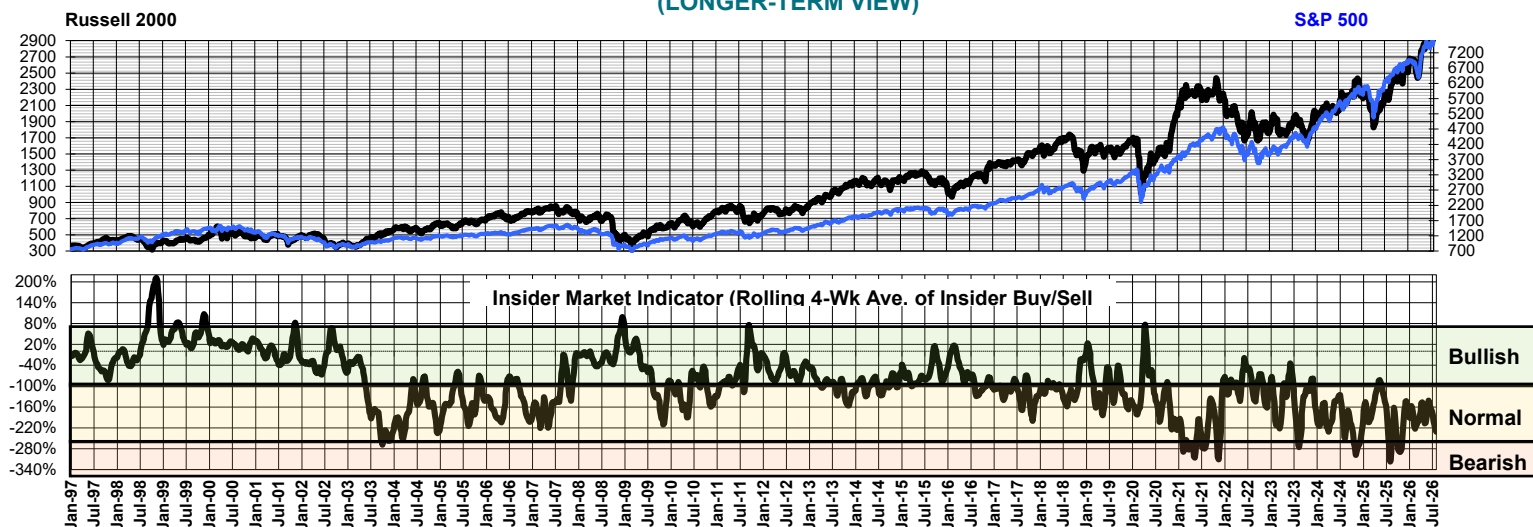
